### Coldwater Indian Band Notice to Members: Election Policy Special Band Meeting

Date: May 1, 2024

The Coldwater Governance and Elections Committees has conducted a review of the Coldwater Indian Band Custom Election Policy (the "Election Policy") and the Coldwater Indian Band Governance Policy (the "Governance Policy"). Chief and Council has considered and reviewed the Committees' proposed amendments.

Amendments to the policies are proposed to improve efficiency, fix inconsistencies or gaps, and provide more transparency for members.

Chief and Council have called for a Special Band Meeting to vote on the proposed amendments to the Coldwater Indian Band Custom Election Policy (the "Election Policy"), in accordance with the procedure in 15.2 of the Election Policy. It this meeting, the Coldwater Indian Band Governance Policy (the "Governance Policy") amendments will also be reviewed with input from Members welcome.

The Special Band Meeting will be held at the following date, time and location:

June 5, 2024 10:00 a.m. 5:00 p.m. Coldwater Band School Gym

Included with this notice is an innotated copy of the proposed amendments to the Election Policy and the Governance Policy Please note that there are yellow text boxes in the policies which outline the specific proposed amendments, but will not form part of the finalized policies.

At the Special Band Meeting, elgible Members will vote on whether the proposed amendments to the Election Policy, as attached to this notice, should be adopted. The proposed amendments will some into force as of the date of the Special Band Meeting if a majority of eligible Members (50% + 1) present at the Special Band Meeting vote in favour of approving the proposed amendments.

Members re eligible to vote if they are:

- egistered member of the Coldwater Indian Band since at least June 8 2023
- Toyears of age or older on June 8 2024

While amendments to the Governance Policy do not require approval by the membership, Chief and Council seek input from members on the Governance Policy at the Special Band Meeting.



# Lateral Kindness Awareness Seminar: June 27-28th

Our 2-day LV2LK Sessions start with identifying what behaviours, impacts and history (*residential school, colonization, inter-generational trauma*) are connected to Lateral Violence, and then move into mapping a group journey to Lateral Kindness. We also examine the process of change and hold the space for gentle self-reflection in these highly interactive sessions. In our experience with today's diverse organizations, dynamics such as bullying and racism are inseparable from Lateral Violence so when addressed in isolation often result in relatively poor outcomes. LV2LK works with these sensitive topics within a larger context by looking at factors that drive behaviours in a psycho-social context, rather than merely "unwanted behaviours" that must be mitigated.

Our approach to addressing Lateral Violence, and Lateral Kindness is one that recognizes and honours the inherent worth of each individual. We look at behaviours associated with Lateral Violence as a sociological effect, rather than personal defects in the individuals. Collective and individual responsibility for positive growth is then explored through self-awareness and skills building (communication, conflict, power). This approach maintains dignity for all, and creates a stronger foundation for mobilizing large-scale growth throughout an organization.



**Neil Burrows**, **RSW** has been working with indigenous groups since 1990, providing professional training, critical incident debriefing, trauma counselling and program consultation. Much of Neils' work centres on Lateral Violence and working with groups to overcome the colonial impacts on their workplace health.

Neil completed his studies at Lakehead University (ON) and the University of Victoria (BC) and currently resides in Williams Lake.



### Carolyn Charleyboy, M.Ed., RCC

A member of the Tsilhqot'in Nation (Tsidedel / Redstone) in the Cariboo region of BC, with 7 years of post-graduate clinical counselling experience, Carolyn brings a uniquely informed Indigenous perspective to her work. Carolyn is trained and certified in *Indigenous Focusing Oriented Therapy* (IFOT), as well as *Cognitive Behavioural Therapy* (CBT), *Eye Movement Desensitization Reprocessing* (EMDR) and *Equine-Assisted Learning* (EAL). Carolyn completed her education at the University of British Columbia (UBC), and the University of Northern British Columbia (UNBC), and currently resides in

Williams Lake. She has delivered Lateral Violence to Lateral Kindness (LV2LK) sessions to multiple First Nation organizations across Canada, and as a trained circle-keeper brings a uniquely calm and trauma-informed approach to this important work.





When reporting to 911 to create files with the R.C.M.P. please make sure you indicate the following:

- 1. What you are reporting or have witnessed.
- 2. Where you witnessed.
- 3. Date and time witnessed.
- 4. Leave a contact number that you can be reached at in case they need to contact you.
- 5. When calling for an ambulance state clearly to 911 the house number, street address or road name and clearly that you are located on the <u>COLDWATER INDIAN BAND</u>.

# Merritt detachment online reporting

Online Crime Reporting | Merritt RCMP (rcmp-grc.gc.ca)

Can also be accessed by the city of Merritt website page under Merritt RCMP online reporting

This is meant to provide citizens with the convenience to report certain crimes online while freeing call takers and frontline staff to focus on the higher priority calls, which improves overall safety and response times in the city. It is important to know that not all crime can be reported

via the online process.

Citizens will be able to report the following crimes online:

- Damage/mischief to property under \$5,000
- Damage/mischief to a vehicle under \$5,000
- Hit and run to an unoccupied vehicle or property
- Theft of bicycle under \$5,000
- . Theft under \$5,000
- Theft from vehicle under \$5,000
- Lost property

Incidents must also satisfy the following conditions to report via the online process:

- No witnesses or suspects.
- Item(s) lost or stolen must cost less than \$5,000
- · Vandalized property or vehicle will cost less than \$5,000 to repair.

There are no items involving personal identity, firearms, licence plates or decals.

We are waiting for an approved budget for the Bands fencing crew for 2024. The Coldwater fencing crew to construct road fence and repair and the completion of Coutlee Plateau summer range unit bordering up to Paul's Basin Reserve. This should take 8-9 weeks of work and cannot guarantee completion due to on coming fire season and weather conditions.

And get ready to reap the benefits for all your hard work, but don't forget to water the plants,

# **Skills to Counteract Lateral Violence**

### **Directions for Lateral Kindness**

Part of healthy communication is making sure that we are speaking with others in respectful and collaborative ways. We can use our words to help or hurt people. When our interactions with people become difficult, it can be easy to get defensive or angry. The list below can help us maintain respectful relationships with our family, friends, colleagues, and community members.

Set a positive tone to create safe spaces. Be kind.
Be direct and say what you have to say in a respectful way.
Utilize cultural practices and protocols to guide how people are treated.
Use "I" statements to state your feeling, describe the behaviour or issue and its effect on you, and ask for what you need.
You have the right to express your ideas, feelings, and needs; remember to also respect the other person's right to their ideas, feelings, and needs.
Ask respectful questions without speaking over. Actively listen and be present.
Ask clarifying questions to get more information and to clarify what the other person means.
Be willing to work things out and believe that things can be worked out. Try to be as cooperative as you can.
Collectively determine positive and creative solutions.
Stay open to all ideas. Agree to disagree when there is a difference of opinion.
Use your sense of humour.
Take responsibility for your own feelings. Avoid using roadblocks to communication like blaming, threatening, shaming, or judging.
Apologize if you need to.
